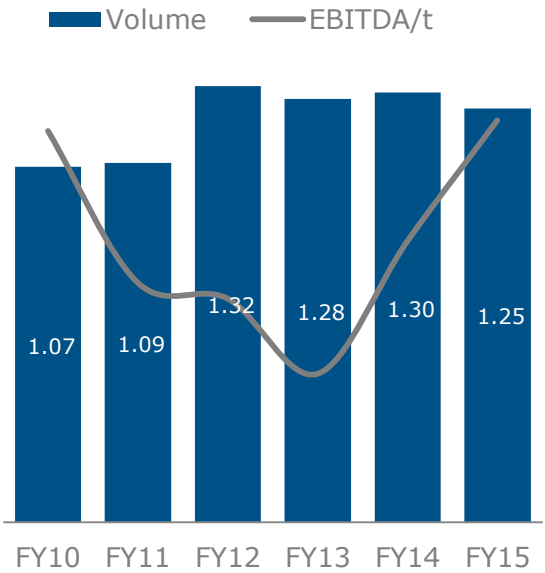

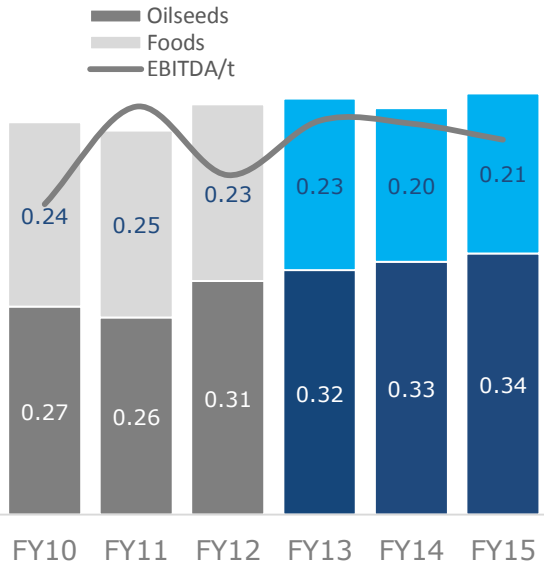

MALT SALES & EBITDA/T<sup>(1)</sup>



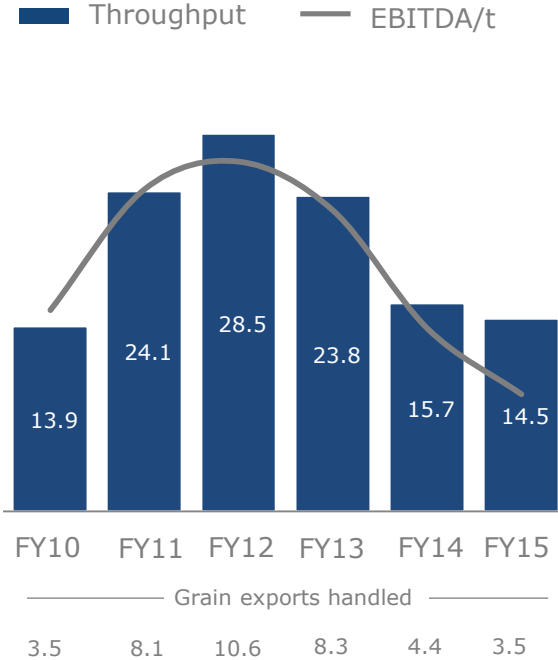
